3.1 The purpose and aims are to ensure all our people can work confidently and safely within relevant UK Legislation, Local Authority guidance and International guidance, and to provide our people with clear direction that ensures individual responsibilities within UK legal and regulatory frameworks that govern safeguarding work.

Children

4.1 Legislation relating to the protection of children is set out in different frameworks across the UK.

England and Wales

The Children Act 2004

Children Act 2004 (legislation.gov.uk)

The act creates a duty for the key agencies who work with children to put in place arrangements to make sure that they take account of the need to safeguard and promote the welfare of children. Whilst this duty is aimed at agencies in the statutory sector, we reference this as good practice.

Working together to safeguard children - GOV.UK (www.gov.uk)

The working together Safeguard Children Guidance recognises that many voluntary agencies are active in taking steps to safeguard the children they engage with. The guidance states that organisations in the voluntary sector that work with children need to have arrangements in place to safeguard children in the same way as organisations in the public sector.

Northern Ireland

The Children (Northen Ireland) order 1995

Sets out the framework for the care and upbringing of children and outlines their rights and responsibilities.

Wales

The Social Services and Well-being Act (Wales) 2014
Social Services and Well-being (Wales) Act 2014 (legislation.gov.uk)

This Act has a broader scope and covers both children and adults. It aims to promote the well-being independence and protection of individuals in need of care and support. It introduced a duty to report to the local authority if any child is suspected of being at risk or experiencing abuse or neglect.

Scotland

The Children and Young People Act (Scotland) 2014,

Part One:Services In Relation To Children At Risk Of Becoming Looked After And The Legal Framework - Children and Young People (Scotland) Act 2014: National Guidance on Part 12: Services in relation to Children at Risk of Becoming Looked After, etc - gov.scot (www.gov.scot)

The Act sets out the legal duties and responsibilities of agencies and professionals involved in protecting children and promoting their welfare. It has also introduced a national guidance called National Guidance for Child Protection in Scotland.

Protection of Children (Scotland) Act 2003 (legislation.gov.uk)

This Act was introduced to establish and maintain a list of persons who are considered unsuitable to work with children.

Isle of Man

Requires the Board to develop policies and procedures for safeguarding and promoting the welfare of children and safeguarding and protecting vulnerable adults.

Jersey

Children (Jersey) Law 2014

Children and Young People (Jersey) Law 2022 (jerseylaw.je)

The Act makes provision to promote and support the wellbeing, and safeguard the welfare, of children and young people and for connected purposes.

Jersey Safeguarding Partnership Board

The Safeguarding Partnership Board has responsibility for promoting understanding of safeguarding, helping agencies to work together to safeguard children and adults at risk, and monitor how effectively agencies are working together to keep adults and children safe.

UK

Female Genital Mutilation (FGM) act 2003,

Female Genital Mutilation Act 2003 (legislation.gov.uk)

Makes it illegal to perform FGM, assist in performing FGM, or to arrange for a girl or woman to undergo FGM. The legislation has been amended for the whole of the UK, placing a duty on professionals to report all known cases of FGM in girls under 18 to the police.

UK

The Terrorism Act 2000 and the Counter Terrorism Act 2008 Counter-Terrorism Act 2008 (legislation.gov.uk)

The Act consists of key pieces of legislation that impose obligations on public bodes to report any suspicions or information related to terrorism or the appropriate authority. Counter terrorism legislation places a duty on public bodies to report to the police where they suspect a person is being radicalised to commit offences.

It is an offence under the Criminal Justice and Courts Act 2015 for an individual who has the care of another individual by virtue of being a care worker to ill-treat or wilfully to neglect that individual.
